# TRAINING CONTRACT AND GENERAL CONDITIONS OF PARTICIPATION

## Article 1 : Object of the contract

This contract is concluded between A.R.C.H.E. SUISSE LLC (hereafter "the training organization" or "A.R.C.H.E. Hypnose Suisse") and the person who subscribes to the training (hereafter "the student" or "the signatory"). The content of the training is chosen by the student after information from the training organization.

The student who signs the contract agrees to read all the provisions of the contract and to respect its content.

## Article 2: Financial Provisions

Each course is subject to a specific fee as outlined in the Registration Form.

Payments are to be made by bank transfer only and in Swiss Francs (CHF), unless otherwise specified by A.R.C.H.E. Hypnose Suisse. Any bank charges are to be paid by the client, i.e. the student.

For Cycle 1 and Cycle 2 Packs, the student can pay in three instalments upon request to A.R.C.H.E. Hypnose Suisse. For all other courses (single modules, thematic workshops, specialization courses, etc.), the full amount is due upon registration.

The registration will only be validated after the first payment has been received. The signatory then has a 10-day withdrawal period, after which the training fees remain due in full and the training dates for which the student has registered cannot be changed or cancelled, except in cases of force majeure.

Subscribing to Cycle 1 offers the possibility to the student to participate freely to three modules of Supervision and Improvement, in a three years delay, starting at the validation of the pre-requisite level for each of these modules.

## Article 3: Total or partial non-performance of the agreement by the organization

The training organization reserves the right to cancel and/or postpone a training session, for pedagogical reasons, or because of an insufficient number of participants. In case of partial or total non-performance of the training action due to A.R.C.H.E. Hypnose Suisse, or within the framework of the COVID, if the health and safety conditions are not met, the student will be able to:

- (i) postpone the registration to another session: any difference in cost must be settled
- (ii) claim a credit note: for the full amount paid
- (iii) claim a full refund: this will be made within a maximum of 90 days starting at the notification of the cancellation/rescheduling of the training.

## Article 4: Total or partial non-performance of the agreement due to the student

In the event of cancellation or withdrawal during the course of training by the student, due to the occurrence of an unforeseeable, irresistible and external event similar to a case of force majeure, the student will then be able to participate again free of charge in the training that could not be validated within a period of three years and move the dates of the following modules if necessary.

The student affected by a force majeure event will immediately notify the training organization. The burden of proof for the occurrence of a force majeure event lies with the student.

In the case of an event that does not qualify as force majeure, the student remains liable for the full amount due for the entire course and may not, where applicable, claim any reimbursement.

## Article 5 : Refusal of registration by the organization

The training organization reserves the right to refuse an application for reasons of personal safety, professional ethics, capacity or any other non-discriminatory reason related to the proper conduct of the professional training phases. Any person presenting a fragility or a disorder incompatible with the training, in particular of a psychiatric or psychological nature, cannot participate in the training and is invited to approach a professional competent in the matter. In case of doubt, the student must inform the training organization in writing at the time of registration. In any case, the student must inform A.R.C.H.E. Hypnose Suisse without delay. A.R.C.H.E. Hypnose Suisse cannot be held responsible for any disorder resulting from a psychological fragility expressed or revealed during or after the training.

## TRAINING CONTRACT AND GENERAL CONDITIONS OF PARTICIPATION

### Article 6: Exclusion of the student

In case of trouble or fragility in the sense of article 5 of this contract and discovered during the training, but also in case of frequent late arrivals, repeated absences, indiscipline or any other behavior incompatible with the good progress of the training, the training organization reserves the right to exclude temporarily or permanently the student.

In such a case, the totality of the training fees remain due and no refund is possible.

### Article 7: Validation of prior learning and training levels

The validation of a training course and the passage to the next level depends on the achievements of each student, which only the training organization is competent to evaluate.

The validation of the technician and practitioner modules has an authority and a value of internal recognition of the training organization and is only possible on demonstration of the theoretical and technical skills of the student. These diplomas and titles do not have the value of a diploma recognized by the State and do not in any way allow the student to claim the quality of psychotherapist or psychologist.

If a module is not validated, the student can participate again at no extra cost, but a maximum of three times.

### Article 8: Distinction of professional competence

The training provided by A.R.C.H.E. Hypnose Suisse can in no way be considered as a complement or an alternative to a medical follow-up within the competence of a regulated profession, and cannot, as such, be used to establish a medical diagnosis.

### Article 9: Exclusion of liability

A.R.C.H.E. Hypnosis Switzerland declines all responsibility for damages that the student may incur during or in connection with the training that is the subject of this contract. By signing this contract, the student expressly acknowledges that he/she has been fully informed about the content, prerequisites and requirements of the training.

A.R.C.H.E. Hypnosis Switzerland assumes no responsibility for the benefits or advantages expected by the student from the training followed, the choice to follow the said training being deemed to respond to an interest identified by the student.

### Article 10: Jurisdiction and applicable law

All legal relations with the training organization are subject to Swiss law, excluding its conflict rules.

In the event of a dispute, the parties agree that the courts of the Canton of Geneva shall have exclusive jurisdiction, with the right to appeal to the Federal Court in Lausanne being reserved.
